General

Insurance certificate

To take out an insurance policy, you must fill out and fax the application form to Landschaftliche Brandkasse Hannover. Separate cover notes will not be issued.

Insured risks and damages / Exclusions

The exhibition insurance is valid during transport to and from the „iF DESIGN AWARD 2020“ as well as during the period of presence at the Schuppen 52, Hamburg and at Café Moskau, Berlin and covers all risks as stated in the General Terms and Conditions for Exhibition Insurance as well as other special conditions and clauses. In particular are insured:

loss or damage caused by accident of the transport vehicle,
fire, storm, tap-water, natural perils like force majeure,
landslide, rockslide, as well as burglary,
theft and malicious damage by third parties.

The insurance policy excludes any operating damages caused during the presentation of exhibits as well as any third party liability claims.

Scratches and damages to paintwork are excluded from the insurance. The cost to repair surface damages of this nature (e.g. filling and painting) will be reimbursed by the insurer only if the surface damage is the direct consequence of an accident involving the means of transport or of any other incidence covered by the terms and conditions of this policy.

Notice of claim

All cases of damage must be reported to the insurer immediately. In cases of theft the responsible police office must also be notified.

The insurance cover comes into effect as soon as the application form has been faxed to the Landschaftliche Brandkasse Hannover. The Landschaftliche Brandkasse Hannover will confirm receipt of your application by mailing you the invoice for the premium. The insurance cover is valid only if the premium is paid immediately upon receipt of the invoice.
